- There is a monthly base Liveaboard rent with an additional charge per person beyond the first person.
- This liveaboard waitlist application is for the individual(s) and boat listed above; if the boat or residents change we will need a new application submitted.
- Guests staying aboard for more than 5 nights must be approved in writing by BYC Management.
- The Waitlist is kept by slip size, and organized by date completed Water Slip Waitlist Application is received in full including waitlist deposit and current photo. When a Liveaboard applicant is next on the waitlist, we will only offer the open slip if it can accommodate a Liveaboard at that time.
- All terms listed on the Water Slip Waitlist Application apply to this Liveaboard Waitlist Application.
- There is a six month minimum for Liveaboard, you will be responsible for payment even if you vacate the slip or move off of the boat. 30 Days notice to vacate is required in writing for Liveaboard AS WELL AS for the slip.
- A Welcome Survey of your boat will be conducted upon arrival. You may be denied approval to stay if the vessel is found to not be seaworthy or is represented differently than on this application. This includes, but is not limited to, boat condition, length overall, beam width, and exterior décor.
- No items are to be stored on the docks. This includes but is not limited to: chairs, kayaks, grills, and plants.
- Getting on the Liveaboard Waitlist does not guarantee entry into the harbor as liveaboard even if the boat is approved. The marina reserves the sole right to decide whether a vessel or applicant is suitable for any given berth. The parties agree that the Marina shall have no liability for refusing to assign any specific berth to any vessel/owner.
- No dogs are allowed to liveaboard boats at Brickyard Cove Marina.
- ALL animals must be on leash or in a locked cage when on the docks or exterior portion of the boat.
- No animals are permitted to enter then restrooms.
- No washing of cars is permitted in our parking lot.
- Each liveaboard boat is permitted a two car maximum for our parking are. There are no designated parking spaces. No storage of unused cars or campers is permitted.
- Communications including offering of slips will be done through the E-mail listed above. It is your responsibility to update the Marina Office if your contact information changes, if we are unable to reach you through the provided e-mail, your deposit will be permanently forfeited.
